Rules & Regulations

- **Eligibility:** This Championship is open to all women residents of West Bengal subject to approval of the concerned District Chess Association.
- Entries/Entry Fee: Only online entries are accepted. However, SBDS will have the right to accept or reject any entry without assigning any reason. Title players (WGM/WIM) are not allowed to play. Two representatives from each affiliated District Chess Association will get a 50% refund after depositing the Full Entry Fee.
- Last Date of Entry: 18th November, 2025 (up to 2-00 pm), after which Entry may be accepted with a Late Fee of Rs.100/- till 19th November, 2025 (up to 7-00 pm)
- System of Play: The Championship will be played under FIDE's Laws of Chess and the Swiss system. Maximum (8) eight rounds shall be played.
- Default Time: Default time for arriving to the chessboard is 30 minutes.
- **Time Control:** The rate of play shall be 90 minutes with an increment of 30 seconds per move from move number one.
- Tie Break: Following is the order of tie-break:
- (a) Buchholz Cut1
- (b) Buchholz
- (c) Sonneborn Berger
- (d) Direct encounter
- (e) The greater number of wins (forfeit included)
- (f) In case of tie, cash prizes will not be shared.
- **Protest:** Protest, if any, against the decision of the Chief Arbiter shall be made in writing with a protest fee of Rs.1500/- by Cash within 15 minutes of the occurrence of the incident. The protest fee will be refunded if the appeal is up held.
- **Appeals Committee:** Before the commencement of the tournament, a three member appeals committee shall be formed by the SBDS/organizers.
- Certificate: All Players will get E-Certificates.
- **Prize Distribution Ceremony:** Prize winners must attend the ceremony to receive their cash prizes or trophies; failure to attend will result in forfeiture.

- **Selection:** Top 4 ranked players will represent West Bengal in the National Women Chess Championship. Interpretation: The Tournament Committee has every right to make any addition or alteration to these rules. However, such changes/ or inclusion will be subject to SBDS clearance. Such changes will, however, be displayed in the tournament hall.
- **Withdrawal:** If any player is absent in any round without written intimation to Chief Arbiter, she will be treated as withdrawn herself.
- **Disqualification:** No participant will leave the venue before the Prize Distribution function without the permission of the Chief Arbiter.
- **Registration of Players**: All participants of this State Championship must have registration with AICF & SBDS for the year 2025-26.
- **Electronic Devices:** All electronic devices including wrist watches (all type of watches) are not allowed in the tournament hall.
- Accommodation: Players will have to arrange their own accommodation.
